To set into motion the implementation of the project “Vehicles for disaster response and rescue activities – Ten (10) units Van (for conversion into a rescue vehicle equipped with the necessary equipment and apparatus), as detailed in the NADAI, an ordinance and a resolution must be passed authorizing and approving the utilization of the portion of the received LGSF-FA to LGUs for FY 2024 for the purchase of the said vehicles.

This August Body finds that the addition of the ten rescue vehicles to the PGI’s vehicle fleet will significantly advance its rescue and disaster response capabilities, to the betterment of the welfare of the Isabeleños.

In line with the foregoing, the immediate approval of this ordinance is earnestly sought.

Section 1. Coverage. This ordinance shall cover the account “Trust Fund – Local Government Support Fund FY 2024” of the Provincial Government of Isabela.

Section 2. Authorization. The utilization of the portion of the Trust Fund – Local Government Support Fund FY 2024 of the PGI, amounting to Nine Million Six Hundred Eighty Seven Thousand Pesos (P9,687,000.00), for the purchase of ten (10) units Brand New FX Type, Rescue Vehicle, 4x2, M/T with 3 Years LTO Registration, valued at Nine Hundred Sixty Eight Thousand Seven Hundred Pesos (P968,700.00) per unit is hereby approved and authorized.


Section 4. Effectivity. This Ordinance shall take effect immediately upon approval


