WHEREAS, the Provincial Government of Isabela supports lawful livelihood opportunities for Isabeleños and adopts measures that promote local enterprise while augmenting provincial revenues through the proper and regulated use of government-owned premises;

WHEREAS, in line with this policy, the Honorable Governor Rodolfo T. Albano III, in his letter to this August Body, requested legislative authority to enter into and sign, for and on behalf of the Provincial Government of Isabela, a Contract of Lease with Joyce Anne P. Ammugauan relative to a designated commercial space within the Provincial Capitol Compound;

WHEREAS, a draft Contract of Lease was presented to this August Body, under which the Provincial Government of Isabela, as LESSOR, shall lease to Joyce Anne P. Ammugauan, as LESSEE, a stall previously utilized as a store located at Capitol Grounds beside Tienda Isabela, Alibagu, City of Ilagan, Isabela, to be used exclusively as a food stall business, for a period of twelve (12) months, renewable and extendable upon mutual agreement of the parties, with a monthly rental of Five Thousand Pesos (₱5,000.00), inclusive of water and electricity charges;

WHEREAS, the proposed lease is intended to generate lawful income for the Provincial Government and, at the same time, provide a business opportunity within the Capitol Compound, subject to the terms and conditions of the lease contract and existing laws, rules, and regulations;

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

WHEREAS, Section 465(b)(1)(vi) of the same Code provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts, obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, after careful review and deliberation, this August Body finds that the proposed Contract of Lease is lawful, just, beneficial, and consistent with the policy of the Provincial Government of Isabela to support local livelihood opportunities and augment provincial revenues.

WHEREFORE, upon motion of the Honorable Manuel Faustino U. Dy, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T. 

WHEREAS, a draft Contract of Lease was presented to this August Body, under which the Provincial Government of Isabela, as LESSOR, shall lease to Joyce Anne P. WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

WHEREAS, Section 465(b)(1)(vi) of the same Code provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts, obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, after careful review and deliberation, this August Body finds that the proposed Contract of Lease is lawful, just, beneficial, and consistent with the policy of the Provincial Government of Isabela to support local livelihood opportunities and augment provincial revenues.


