WHEREAS, the Provincial Government of Isabela and the 54th Infantry (Magilas) Batallion, 5th Infantry (Star) Division of the Philippine Army intends to conduct a voluntary blood donation drive, in furtherance of their shared goal of maintaining a steady and reliable supply of blood and blood products in the province;

WHEREAS, in pursuit of their mutual objective, they have agreed to enter into a Memorandum of Agreement that establishes their respective roles and responsibilities to ensure the successful conduct of the voluntary blood donation drive, a copy of which has been submitted to this August Body for its review and approval;

WHEREAS, Section 465(b) (1) (vi) of R. A. No. 7160 empowers the Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the PGI and the 54th Infantry (Magilas) Batallion, 5th Infantry (Star) Division of the Philippine Army providing their respective duties and functions on the implementation of the aforementioned award;

WHEREAS, after a careful review, this Honorable Body finds the provisions of the proposed Memorandum of Agreement to be lawful, beneficial, and consistent with the health policies of the Provincial Government of Isabela, thereby warranting the issuance of an authority for the Honorable Governor to sign the same on behalf of the Province;

WHEREFORE, upon the motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
