A RESOLUTION DECLARING ORDINANCE NO. 2025-1473 (SUPPLEMENTAL BUDGET NO. 5 FY 2025) IN THE AMOUNT OF SIXTEEN MILLION SEVEN HUNDRED TWENTY NINE THOUSAND PESOS (P16,729,000.00) OF THE MUNICIPALITY OF SAN MARIANO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITION

WHEREAS, Appropriation Ordinance No. 2025-1473, entitled “An Ordinance Authorizing Supplemental Budget No. 05 for CY 2025 Under the General Fund of the Municipality of San Mariano, Isabela in the Total Amount of **SIXTEEN MILLION SEVEN HUNDRED TWENTY NINE THOUSAND PESOS (P16,729,000.00)**” out of the declared savings from Personal Services (vacant positions) and MOOE for the Grant of Collective Negotiation Agreement Incentives (CNAI), Service Recognition Incentives (SRI), Gratuity Pay to COS and JOs and for the implementation of priority programs and projects of the Local Government of San Mariano, Isabela, was submitted to this Sanggunian for review pursuant to Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of SP Member **EVYN JAY C. DIAZ** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2025-1473 (Supplemental Budget No. 5 FY 2025) of the Municipality of San Mariano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160, and subject further to the following conditions:

1. The appropriation for the grant of *Collective Negotiation Agreement (CNA)* in the amount of Nine Million Four Hundred Fifty Thousand Pesos (P9,450,000.00) shall be in accordance with DBM Budget Circular No. 2025-2, dated November 19, 2025, the Guidelines on the Grant of the Collective Negotiation Agreement (CNA) Incentive for FY 2025;
2. The appropriation for the grant of *Other Personnel Benefits - Service Recognition Incentive (SRI)* in the amount of Six Million Two Hundred Twenty Eight Thousand Pesos (P6,228,000.00) shall be in accordance with Administrative Order No. 40 by the President of the Philippines, dated December 11, 2025, Authorizing the Grant of Service Recognition Incentive to Government Employees for Fiscal Year 2025 and DBM Budget Circular No. 2025-3, dated December 15, 2025, the Guidelines on the Grant of Service Recognition Incentive to Government Employees for FY 2025;
3. The appropriation for *Overtime and Night Pay* in the amount of Sixty Thousand Pesos (P60,000.00) shall be in accordance with the guidelines of CSC-DBM Joint Circular No. 2, series 2015 dated November 25, 2015, on the Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees;
4. The appropriation for the grant of Gratuity Pay to Contract of Service and Job Order Workers in the amount of Nine Hundred Thirty One Thousand Pesos (P931,000.00) shall be in accordance with Administrative Order No. 39 issued by the President of the Philippines, dated December 11, 2025, Authorizing the Grant of Gratuity Pay to Contract of Service and Job Order Workers in Government for Fiscal Year 2025 and DBM Budget Circular No. 2025-4 dated December 16, 2025, the Guidelines on the Grant of Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in Government for Fiscal Year 2025;

RESOLVED FURTHER, to require the Municipality of San Mariano, Isabela to comply with the conditions herein set forth.


RESOLVED FURTHER, to inform the Municipality of San Mariano, Isabela that this review action does not authorize any item or items of appropriation that are specifically prohibited by, or inconsistent with the provisions of law, and that compliance with all existing laws, rules and regulations shall remain the responsibility of the Local Government

Unit, and that all disbursements of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable ANA CRISTINA S. GO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of San Mariano, Isabela through the **Honorable EDGAR T. GO**, Municipal Vice Mayor.


