AN ORDINANCE AUTHORIZING THE REPROGRAMMING OF THE AMOUNT OF SEVEN HUNDRED FIFTY THOUSAND PESOS (₱750,000.00), REPRESENTING A PORTION OF THE UNEXPENDED BALANCES FROM THE 20% DEVELOPMENT FUND FOR FISCAL YEAR 2015, ORIGINALLY ALLOCATED UNDER THE ACCOUNT 'PGI EQUITY EVACUATION CENTER PAILAW AND PATUBIG,' TO BE REALLOCATED FOR THE 'INSTALLATION OF A SOLAR-POWERED WATER PUMP FACILITY WITH HOLDING DRUMS AT BARANGAY BIGA OCCIDENTAL, STO. TOMAS, ISABELA'

EXPLANATORY NOTE

This proposed ordinance aims to authorize the reprogramming of Seven Hundred Fifty Thousand Pesos (₱750,000.00), representing a portion of the unexpended balance from the 20% Development Fund for Fiscal Year 2015. Said amount forms part of the original allocation of Three Million Pesos (₱3,000,000.00) under the account "PGI Equity Evacuation Center Pailaw and Patubig."

The original project is no longer feasible and cannot be implemented as initially planned, resulting in unutilized appropriations. In order to maximize available government resources and ensure that public funds are directed toward more urgent and relevant development priorities, the Provincial Governor has proposed the realignment of a portion of the said unexpended funds.

The reallocated amount will be used for the Installation of a Solar-Powered Water Pump Facility with Holding Drums at Barangay Biga Occidental, Sto. Tomas, Isabela. This project seeks to address the community's need for a sustainable and reliable water supply system, particularly in areas where access to potable water remains a continuing problem.

This initiative is consistent with the objectives of the 20% Development Fund, which prioritizes programs and projects that contribute to socio-economic development and improve the quality of life of our constituents.

In view of the foregoing, approval of this ordinance is earnestly sought.

Section 1. Coverage. This Ordinance shall cover the items, accounts, and appropriations provided in Section 2 hereof.

Section 2. Reprogramming of Funds. That a portion of the unexpended balances in 20% Development Fund of the Provincial of Isabela for Fiscal Year 2015, as provided below is hereby reprogrammed as follows:

Section 3. Utilization of Funds. The disbursement and utilization of funds to be made pursuant to this Ordinance shall adhere to existing government budgeting, accounting, and auditing laws, rules, and regulations.

Section 4. Authority to Reprogram. To ensure that the resources and development plans of the Provincial Government of Isabela are responsive to the current development issues and that its programs, plans, and activities are effectively implemented, the Governor is hereby empowered to augment or reprogram any savings that may be derived from the herein reprogrammed funds to any item within the same appropriation.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.


