WHEREAS, the Office of the President, through the Socio-Civic Projects Fund (SCPF), is authorized to extend financial assistance to Local Government Units (LGUs) in support of social development-oriented priority projects;

WHEREAS, under the “Bawat Barangay Makikinabang” Program, each barangay is allocated Two Hundred Thousand Pesos (PHP 200,000.00) to implement immediate, high-impact interventions such as educational assistance and public service projects;

WHEREAS, the Province of Isabela has a total of Five Hundred Fifty-Three (553) qualified barangays, each entitled to receive financial assistance in the amount of Two Hundred Thousand Pesos (PHP 200,000.00), for a total allocation of One Hundred Ten Million Six

DY, TO ACCEPT AND SIGN THE DEED OF DONATION ENTERED INTO BY AND BETWEEN THE OFFICE OF THE PRESIDENT (OP), AS DONOR, AND THE PROVINCIAL GOVERNMENT OF ISABELA, AS DONEE, FOR THE DONATION AND ACCEPTANCE OF FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED TEN MILLION SIX HUNDRED THOUSAND PESOS (PHP 110,600,000.00), REPRESENTING TWO HUNDRED THOUSAND PESOS (PHP 200,000.00) PER BARANGAY, SOURCED FROM THE SOCIO-CIVIC PROJECTS FUND (SCPF), FOR THE IMPLEMENTATION OF EDUCATIONAL ASSISTANCE AND BARANGAY DEVELOPMENT PRIORITIES

Hundred Thousand Pesos (PHP 110,600,000.00), intended to support educational assistance and barangay-identified development priorities under the “Bawat Barangay Makikinabang” Program;

WHEREAS, the Office of the President has approved the grant of financial assistance in favor of the barangays of the Province of Isabela, in the total amount of One Hundred Ten Million Six Hundred Thousand Pesos (PHP 110,600,000.00), representing Two Hundred Thousand Pesos PHP 200,000.00 per barangay, to be formalized through a Deed of Donation to be entered into by and between the Office of the President and the Provincial Government of Isabela;

WHEREAS, the said financial assistance shall be utilized for the following purposes:

Assistance	Amount (in PHP)	Conditions
Bagong Pilipinas Barangay Scholars	100,000.00	To provide PHP 20,000.00 educational assistance each to five (5) qualified student beneficiaries who are incoming fourth-year college students
Barangay-Identified Development Priorities	100,000.00	To support barangay programs, activities, or equipment consistent with community development priorities

WHEREAS, the Sangguniang Panlalawigan of Isabela affirms the willingness and capacity of the Provincial Government of Isabela to accept and administer the financial assistance and to comply with all terms and conditions set forth in the Deed of Donation and applicable laws, rules, and regulations;

WHEREAS, at the time material to the approval and implementation of this Resolution, Governor Rodolfo T. Albano III was engaged in commitments and undertakings in furtherance of the interests of the Province of Isabela, thereby necessitating the assumption of official duties by Vice Governor Hon. Francis Faustino A. Dy, pursuant to existing laws, rules, and regulations governing local government administration;

WHEREAS, it is necessary to authorize the Acting Governor, Hon. Francis Faustino A. Dy, to enter into, sign, and accept the Deed of Donation for and on behalf of the Provincial Government of Isabela to ensure the proper acceptance, lawful utilization, and auditing of the donated funds in accordance with existing laws, rules, and regulations;

WHEREAS, pursuant to Section 2.8 of Office Order No. 20, Series of 2026, otherwise known as the “Revised General Guidelines on the Management and Administration of the Socio-Civic Projects Fund (SCPF),” the Office of the President may extend Special Financial
