A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 07-2025 (SUPPLEMENTAL BUDGET NO. 04-2025) IN THE AMOUNT OF ONE MILLION TWO HUNDRED THIRTY-ONE THOUSAND ONE HUNDRED FORTY TWO PESOS & 96/100 (₱1,231,142.96) OF THE MUNICIPALITY OF BURGOS, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

WHEREAS, Appropriation Ordinance No. 07-2025, entitled “An Ordinance Authorizing the Appropriation of Supplemental Budget No. 04-2025 in the amount of **One Million Two Hundred Thirty One Thousand One Hundred Forty Two Pesos & 96/100 (₱1,231,142.96)**, derived from the unappropriated balance of the 2025 Annual Budget for the funding of various Programs, Projects, and Activities (PPAs) of the Municipality of Burgos, Isabela,” was submitted to this *Sanggunian* for review pursuant to Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 07-2025 (Supplemental Budget No. 04-2025) of the Municipality of Burgos, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The utilization of **Terminal Leave Benefits** and Monetization of Leave Credits shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC MC No. 41 s. 1998, BC 2013-1 dated April 12, 2013, BC No. 2016-2 dated March 29, 2016;
2. Loyalty Pay shall be pursuant to CSC Memorandum Circular No. 6, s. 2002 dated March 1, 2002 — ₱10,000 for the first ten (10) years of government service and ₱5,000 for every succeeding five (5) years thereafter — chargeable against Other Personnel Benefits (5-01-04-990);
3. The grant of the Performance-Based Bonus (PBB) shall be governed by the provisions of DILG-DBM Joint Memorandum Circular No. 2025-001, dated April 30, 2025. This issuance outlines the eligibility requirements, performance indicators, and compliance conditions that must be satisfied by local government units (LGUs) and their personnel in order to qualify for the PBB;
4. That all procurement activities shall be governed by the existing procurement laws, rules and regulations.

RESOLVED FURTHER, to require the Municipality of Burgos, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Burgos, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable KERVIN FRANCIS G. UY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Burgos, Isabela through the **Honorable RUBEN A. GRAGASIN**, Municipal Vice-Mayor.


