WHEREAS, Section 34 of the Republic Act No. 7160 or the Local Government Code of 1991 mandates that Local Government Units (LGUs) support the creation and operation of people's organizations (POs), civil society organizations (CSOs) and non-governmental organizations (NGOs), enabling their active participation in the promotion of local autonomy.;

WHEREAS, Article 62, Rule XIII of the Implementing Rules and Regulations (IRR) of R.A. 7160 strengthens the aforementioned provision, emphasizing that Civil Society Organizations (CSOs) should be included in the planning and execution of local government projects and activities. This includes participation in local special bodies (LSBs) and assisting in the delivery of public services;
