ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO APPROVE AND EXECUTE THE PERFORMANCE COMMITMENT FOR HEALTH FACILITIES OF CAUAYAN DISTRICT HOSPITAL IN COMPLIANCE WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) REQUIREMENTS FOR THE IMPLEMENTATION OF THE YAMAN NG KALUSUGAN PROGRAM (YAKAP) AND GUARANTEED AND ACCESSIBLE MEDICATION FOR OUTPATIENT TREATMENT (GAMOT) ACCREDITATION

WHEREAS, Republic Act No. 11223, otherwise known as the “*Universal Health Care Act*”, institutionalizes universal health care for all Filipinos through equitable access to quality and affordable health care goods and services and protection against financial risk;

WHEREAS, consistent with said policy, the Provincial Government of Isabela (PGI) continuously supports programs and initiatives that promote equitable access to quality, affordable, and responsive health care services for all Isabeleños, particularly the poor, vulnerable, and marginalized sectors;

ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO APPROVE AND EXECUTE THE PERFORMANCE COMMITMENT FOR HEALTH FACILITIES OF CAUAYAN DISTRICT HOSPITAL IN COMPLIANCE WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) REQUIREMENTS FOR THE IMPLEMENTATION OF THE YAMAN NG KALUSUGAN PROGRAM (YAKAP) AND GUARANTEED AND ACCESSIBLE MEDICATION FOR OUTPATIENT TREATMENT (GAMOT) ACCREDITATION

WHEREAS, the Cauayan District Hospital is a duly registered Level 1 health care facility owned and operated by the PGI, duly accredited by PhilHealth, and mandated to deliver accessible, affordable, efficient, and quality health care services to the people through a safe and competent health facility, giving priority to the poor and marginalized sectors;

WHEREAS, PhilHealth YAKAP (Yaman ng Kalusugan Program para Malayo sa Sakit) is the Philippine Government's comprehensive primary health care package and an upgraded, expanded version of the former *Konsulta Program*, designed to prevent severe illnesses and reduce out-of-pocket medical costs for Filipinos by focusing on early disease detection and routine monitoring;

WHEREAS, pursuant to PhilHealth Circular No. 2025-0013, the Philippine Health Insurance Corporation launched the Guaranteed and Accessible Medications for Outpatient Treatment (GAMOT) Package, which grants *Twenty Thousand Pesos* (P20,000.00) worth of medicines for outpatient conditions such as infections, asthma, diabetes, hypertension, cardiovascular diseases, and other related health concerns;

WHEREAS, the Philippine Health Insurance Corporation (PhilHealth) implements various health programs designed to improve access to health care services, including the Yaman ng Kalusugan Program (YAKAP) and the Guaranteed and Accessible Medications for Outpatient Treatment (GAMOT) Program;

WHEREAS, participation in said programs requires the submission and execution of a Performance Commitment for Health Facilities, signifying the commitment of the concerned health facility to comply with PhilHealth policies, rules, regulations, and accreditation requirements;

WHEREAS, the Cauayan District Hospital seeks accreditation under the YAKAP and GAMOT Programs of PhilHealth, for which the submission and execution of a Performance Commitment is a mandatory requirement that will enable the hospital to participate in said programs and provide corresponding health care services and benefits to qualified PhilHealth members and their dependents;

WHEREAS, the Office of the Governor submitted to this August Body a draft Performance Commitment for Health Facilities to be approved and executed by the Honorable Governor Rodolfo T. Albano III;

WHEREAS, upon careful review of the Performance Commitment, this August Body finds the same to be beneficial and advantageous to the Provincial Government of Isabela and its people, as it will further enhance the delivery of medical services in the province to the clear benefit of the public;

WHEREAS, under Section 465 (b)(i) of R.A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;
