Presented for the approval of this August Body is a request from the Provincial Governor, the Honorable Rodolfo T. Albano III, for the reprogramming of funds involving a change in allotment classification affecting specific Programs, Projects, and Activities (PPAs) under the PGO – Other Programs, Projects and Activities of the PGI Annual Budget for year 2025.

Specifically, the amount of **Seven Hundred Thousand Pesos (₱700,000.00)** originally appropriated under the **Capital Outlay (CO)** classification for the PPA “**Animal Health Services**” is requested to be reprogrammed to the **Operation and Maintenance of the Isabela Animal Diseases Diagnostic Laboratory**, which falls under **Maintenance and Other Operating Expenses (MOOE)**.

This August Body recognizes that the revised allocation reflects a shift in operational needs from capital investment to recurring operational support, particularly in sustaining the continuous functioning of the Isabela Animal Diseases Diagnostic Laboratory—an essential facility that provides timely diagnostic services to safeguard animal health in the province.

The proposed reprogramming is in line with the principles of responsive and efficient public financial management, enabling the Provincial Government to adapt to emerging operational requirements and ensure that vital public services remain uninterrupted.

In view of the foregoing, the immediate enactment of this Ordinance is earnestly sought.
