AN ORDINANCE AUTHORIZING THE REPROGRAMMING OF THE 20% DEVELOPMENT FUND (CONTINUING), FROM THE REHABILITATION OF ECHAGUE GRAINS CENTER PHASE II AMOUNTING TO THIRTY MILLION SIX HUNDRED FIFTY THOUSAND (P30,650,000.00) TO FUND THE THREE (3) PROJECT/PROGRAMS/ACTIVITIES

EXPLANATORY NOTE

Section 287 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," mandates that twenty percent (20%) of the annual internal revenue allotment (IRA) of local government units shall be appropriated for development projects.

The 20% Development Fund (Continuing) for Fiscal Year 2023 has an existing allocation amounting to Thirty Million Six Hundred Fifty Thousand Pesos (₱30,650,000.00) intended for the Rehabilitation of Echague Grains Center Phase II, Echague, Isabela.

Upon evaluation, the Provincial Government of Isabela has determined that the said project is no longer immediately necessary and finds it more urgent and beneficial to reprogram the funds toward PPAs that address current needs and promote public welfare.

The Local Finance Committee (LFC) and the concerned offices have reviewed and recommended the reprogramming of the said funds in accordance with existing budgeting, accounting, and auditing rules and regulations.

the proposed reprogramming will allocate the amount of ₱30,650,000.00 to the following priority projects/programs/activities:

1. Purchase of Lot for Echague District Hospital – ₱23,000,000.00
2. Construction of Quezon Public Market – ₱5,000,000.00
3. Purchase of Parcels of Lot for the Expansion of the Isabela Rice Processing Complex at Ipil, Echague – ₱2,650,000.00

The Sangguniang Panlalawigan finds the proposed reprogramming to be compliant with applicable laws and necessary to promote sustainable development and improved public services.

As such, the enactment of this ordinance is earnestly sought.

Section 1. Coverage. This Ordinance shall cover the items, accounts, and appropriations provided in Section 2 hereof.

Section 2. Reprogramming of Funds. The amount of **₱30,650,000.00** previously appropriated under the 20% Development Fund (Continuing) is hereby reprogrammed as follows:

Section 3. Utilization of Funds. The utilization of funds to be made pursuant to this Ordinance shall adhere to existing government budgeting, accounting, and auditing laws, rules, and regulations.


Section 4. Authority to Reprogram. To ensure that the resources and development plans of the Provincial Government of Isabela are responsive to the current development issues and that its programs, plans, and activities are effectively implemented, the Governor is hereby empowered to augment or reprogram any savings that may be derived from the herein reprogrammed funds to any item within the same appropriation.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.


