**AN ORDINANCE APPROVING AND ADOPTING THE PROVINCIAL DEVELOPMENT COUNCIL (PDC) EXECUTIVE COMMITTEE RESOLUTION NO. 06, SERIES OF 2025, THEREBY APPROVING THE REPROGRAMMING OF APPROPRIATION BALANCES FROM LOAN AMORTIZATION AND INTEREST PAYMENTS AND VARIOUS INFRASTRUCTURE ACCOUNTS UNDER THE 20% DEVELOPMENT FUND (CURRENT) OF THE PROVINCIAL GOVERNMENT OF ISABELA TO THE RICE ASSISTANCE PROGRAM AMOUNTING TO THIRTEEN MILLION SEVEN HUNDRED EIGHTY-EIGHT THOUSAND SIX HUNDRED FIFTY-FOUR PESOS AND 01/100 (₱13,788,654.01)**

**EXPLANATORY NOTE**

This proposed ordinance seeks to approve the reprogramming of Thirteen Million, Seven Hundred Eighty-Eight Thousand Six Hundred Fifty-Four Pesos and 01/100 (₱13,788,654.01) representing appropriation balances from (a) loan amortization and interest payment accounts and (b) various infrastructure accounts under the 20% Development Fund (Current) of the Provincial Government of Isabela.

The subject funds were previously appropriated for specific obligations and projects. However, as reflected in the submitted request and supporting schedules, certain items now carry remaining appropriation balances which may be realigned — without creating new appropriations — toward a more urgent and immediately responsive public need.

In this regard, the Provincial Development Council (PDC) Executive Committee, through PDC Executive Committee Resolution No. 06, series of 2025, has approved the proposed reprogramming and realignment to the Rice Assistance Program, recognizing the urgency of cushioning families and vulnerable sectors from the continuing increase in the cost of essential goods and services. A Supplemental Annual Investment Program (AIP) has likewise been prepared reflecting the inclusion of the Rice Assistance Program under the Social Services Sector, consistent with the approved PDC action.

Accordingly, this measure enables the Provincial Government to utilize existing balances efficiently, transparently, and lawfully, converting idle or residual appropriations into direct, time-sensitive relief that benefits the people of Isabela.

As such, the immediate enactment of this ordinance is earnestly sought.

**SECTION 1. Approval and Adoption of PDC Action.** PDC Executive Committee Resolution No. 06, series of 2025, approving the reprogramming herein stated, is hereby approved and adopted. The corresponding Supplemental Annual Investment Program (AIP) covering the Rice Assistance Program is likewise recognized and adopted as part of the planning and investment basis for this Ordinance.

**SECTION 2. Coverage.** This Ordinance shall cover the accounts and appropriation balances stated in Section 3 hereof.

**SECTION 3. Reprogramming of Amounts.** That the total amount of ₱13,788,654.01, representing appropriation balances from the following accounts under the 20% Development Fund (Current) of the Provincial Government of Isabela:

**SECTION 6. Effectivity.** This Ordinance shall take effect immediately upon its approval.






