REORGANIZING THE PROVINCIAL BIDS AND AWARDS COMMITTEE

WHEREAS, Republic Act 12009 also known as "The New Government Procurement Act", an Act revising Republic Act 9184 otherwise known as "The Government Procurement Reform Act", provides for the creation of the Provincial Bids and Awards Committee (PBAC) and its composition;

WHEREAS, to further professionalize and harmonize procurement procedures and standards, the Governor issued an Executive Order establishing the BAC which was mandated to be primarily responsible for the conduct of the prequalification of contractors, bidding, evaluation of bids, and the recommendation of awards concerning local procurement;

WHEREAS, Section 44 of R.A. 12009 states that there shall be a procurement unit, division in each Procuring Entity which shall serve as Secretariat of the BAC and perform other functions related to procurement as may be delegated by the Head of Procuring Entity;

WHEREAS, there is a need to reorganize the committee for the continuing effective implementation of the different BAC activities and programs and to further rationalize the operation of the BAC in line with the latest development in procurement pursuant to Republic Act 12009;

NOW, THEREFORE, I, RODOLFO T. ALBANO III, Governor of Isabela, by virtue of the powers vested in me by Law, do hereby reorganize the Provincial Bids and Awards Committee as follows:
