CREATING THE PROVINCIAL PUBLIC-PRIVATE PARTNERSHIP UNIT OF THE PROVINCE OF ISABELA

WHEREAS, the State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments. To this end, the State shall provide an enabling environment for the private sector to mobilize its resources to finance, design, construct, operate, and maintain infrastructure or development projects and services.

WHEREAS, the State shall protect the public interest by providing affordable, accessible, and efficient public services. In order to achieve better quality of Public-Private Partnership (PPP) Projects at lower costs, the State shall ensure equitable risk allocation in PPP Projects, and that all PPP Projects yield sufficient Value for Money (VFM), promote sustainability, and advance public welfare.

WHEREAS, section 29 of Republic Act No. 11966 (Public-Private Partnership Code of the Philippines) and section 12 of the PPP Code Implementing Rules and Regulations (IRR) encourages the Head of the Implementing Agency to establish PPP Unit which shall plan, oversee, and monitor PPP projects of the Implementing Agency.

NOW, THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the authority vested in me by law, do hereby create and constitute the Provincial Public-Private Partnership Unit (PPP Unit) of the Province of Isabela as follows:

Section 1. Creation. The Provincial Public-Private Partnership Unit (PPP Unit) is hereby created pursuant to R.A. 11966 and its IRR.

Section 2. Composition. The PPP Unit shall be composed of the following:

Section 3. Functions and Responsibilities. The PPP Unit shall perform the following functions:

1. Shall develop lists of programs and projects that may be subject of a PPP arrangement;
2. Shall assess proposals for PPP Projects and submit recommendations thereof to the Governor and the Provincial Development Council for confirmation;
3. Shall oversee and monitor all PPP Projects implemented by the PGI;
4. Shall ensure that proposals for PPP arrangement is in accordance with the requirements of the PPP Code and its IRR;
5. Shall provide reports to the Governor and the PPP Center regarding PPP Projects;
6. Shall comply with other reporting and monitoring processes and procedures as may be required by the PPP Center in accordance with the PPP Code.
7. Perform such other functions which are deemed necessary consistent with the PPP Code and its IRR, the Local Government Code and other related laws.

Section 4. Budget. Necessary funding allocation shall be provided for the operation and maintenance to carry out the smooth implementation and management of the PPP projects.

Section 5. Effectivity. This Executive Order shall take effect immediately unless otherwise amended or revoked.
