REORGANIZING THE PUBLIC-PRIVATE PARTNERSHIP PRE-QUALIFICATION BIDS AND AWARDS COMMITTEE (PBAC) OF THE PROVINCE OF ISABELA

WHEREAS, the State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments. To this end, the State shall provide an enabling environment for the private sector to mobilize its resources to finance, design, construct, operate, and maintain infrastructure or development projects and services.

WHEREAS, the State shall protect the public interest by providing affordable, accessible, and efficient public services. In order to achieve better quality of Public-Private Partnership (PPP) Projects at lower costs, the State shall ensure equitable risk allocation in PPP Projects, and that all PPP Projects yield sufficient Value for Money (VFM), promote sustainability, and advance public welfare.

WHEREAS, section 8 of Republic Act No. 11966 (Public-Private Partnership Code of the Philippines) and section 55 of the PPP Code Implementing Rules and Regulations (IRR) mandates the Head of the Implementing Agency undertaking PPP projects to create a PPP Pre-qualification, Bids and Awards Committee (PBAC);

WHEREAS, there is a need to re-organize the PBAC to implement the mandates of the PPP Code and its IRR;

NOW, THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the authority vested in me by law, do hereby re-organize the PPP Pre-qualification, Bids and Awards Committee (PBAC) of the Province of Isabela as follows:

Section 1. Creation. The PPP Pre-qualification, Bids and Awards Committee (PBAC) of the Province of Isabela is hereby created pursuant to R.A. 11966 and its IRR.

Section 2. Composition. The PBAC shall be composed of the following:

Section 3. Roles and Responsibilities. The PBAC shall be responsible for all aspects of pre-bidding and bidding process, including among others:

1. Preparation of the tender documents;
2. Publication of the Invitation to Pre-qualify and bid;
3. Pre-qualification of Prospective bidders;
4. Conduct of pre-bid conferences and issuance of supplemental notices;
5. Interpretation of the rules regarding bidding;
6. Conduct of bidding;
7. Evaluation of bids;

8. Resolution of dispute between bidders;
9. Recommendation for the acceptance of the bid and/or for the award of the PPP Contract;
10. Such other acts not specifically mentioned herein which are deemed necessary in order to give full effect to the responsibilities mentioned above.

Section 4. Budget. Necessary funding allocation shall be provided for the operation and maintenance to carry out the smooth pre-bidding, bidding, and post bidding process of PPP Projects.

Section 5. Effectivity. This Executive Order shall take effect immediately unless otherwise amended or revoked.
