Section 2. Functions of the Technical Working Group (TWG). The TWG shall exercise the following duties and functions:

- a) Ensure the availability of data needed for the updating of the Provincial Revenue Code of the Province of Isabela 2014;
- b) Formulate the necessary amendments to the provisions of the Provincial Revenue Code of the Province of Isabela 2014;
- c) Request assistance from other concerned offices and/or agencies in the updating of Provincial Revenue Code of the Province of Isabela 2014;
- d) Update the fees and charges imposed by the concerned PGI offices for the provision of services, issuance of documents and other permits, using the Local Fees and Charges Toolkit of the Department of Finance; and
- e) Perform other tasks as may be necessary.

Section 4. Functions of the Secretariat. The Secretariat shall perform the following:

- a) Compile all information, data and materials related to the revision of the Provincial Revenue Code of the Province of Isabela 2014;
- b) Arrange and coordinate meetings with the Technical Working Group;
- c) Record all proceedings and discussions that may arise from the meetings;
and
- d) Perform such other tasks and functions as may be necessary.

Section 5. Submission of Update. The Technical Working Group shall submit updates and accomplishments regarding the proposed revisions of the Provincial Revenue Code of the Province of Isabela 2014 to the Provincial Governor within three (3) months from the approval of this Order.

Section 6. Meetings. The Technical Working Group and its Secretariat shall meet as often as necessary in order to complete their duties and functions.

Section 7. Funding. Administrative expenses of the Technical Working Group and its Secretariat shall be charged against the budgeted fund of the Governor's Office.

Section 8. Repealing Clause. All executive orders, rules and regulations and other issuances including other parts thereof inconsistent with the provisions of this Executive Order are hereby repealed and/or modified accordingly.

Section 9. Separability Clause. If any portion of this Executive Order is declared unconstitutional or invalid, other parts of the provision thereof which are not affected shall continue to remain in full force and effect.

Section 10. Effectivity. This Executive Order shall take effect immediately upon its approval.
